ANNUAL REPORT ON CONSTRUCTION WORKS AT CONSTRUCTIONS (GRAĐ-11)

LEGAL BASIS

The survey is carried out pursuant to the Law on Statistics of Republika Srpska ("Official Gazette of Republika Srpska", No. 85/03) and the Statistical Programme of Republika Srpska for the period 2022-2025.

METHODOLOGICAL BASIS

AIM AND CONTENT

The aim of the survey is to provide annual data on constructions (location, investor, type of works, name and code of the construction according to the Classification of types of constructions), buildings (construction size, purpose, number of floors, installation, useful area of non-residential space) and dwellings (dwellings finished during the reporting year, by number of rooms and useful area, as well as number of dwellings per floor).

OBSERVATION UNITS/REPORTING UNITS

Data are submitted by business entities whose main activity, according to the Classification of Economic Activities KD BiH 2010 based on the EU Statistical Classification of Economic Activities NACE Rev.2, is classified into the section G-Construction, as well as by construction units in composition of non-construction business entities.

COVERAGE

This statistical survey covers business entities which perform construction works in the country.

METHOD AND PERIOD OF DATA COLLECTION

Data are collected annually, using the reporting method.

PROTECTION OF CONFIDENTIAL DATA

Only aggregate data for the level of Republika Srpska are published. Confidential data are protected pursuant to Articles 25 and 27 of the Law on Statistics of Republika Srpska ("Official Gazette of Republika Srpska", No. 85/03) and in accordance with the Rules of protection of confidential data.

DEFINITIONS OF MAIN CHARACTERISTICS – INDICATORS

Construction activity includes preparatory works, buildings and civil engineering, building of complete constructions and their parts, installation works, finishing works and rental of equipment for building or demolition with an operator.

Value of performed works covers all built in construction materials and labour force. It excludes value of land purchase, architects' or consultants fees and VAT. Data on value of performed works refer to works performed during the year on completed and non-completed constructions. Value of performeds work is shown on the basis of annual account statements.

Average number of workers at construction sites covers all workers during the observation period, regardless of type of employment.

Performed hours of work at construction sites are hours performed during the observation period, in regular and overtime work.

IMPLEMENTATION ORGANISATION

AUTHORITIES IMPLEMENTING THE STATISTICAL SURVEY

The authorised producer of data is the Republika Srpska Institute of Statistics.

Collection of data is carried out in the regional offices of the Republika Srpska Institute of Statistics, while entry and processing of data are the responsibility of the Division for Production Statistics of the Institute.

OBLIGATION TO PROVIDE DATA

Reporting units are obliged to submit data to the Republika Srpska Institute of Statistics pursuant to the Law on Statistics of Republika Srpska.

IMPLEMENTATION FREQUENCY

Reporting units are obliged to submit data to the relevant regional office of the Republika Srpska Institute of Statistics until 30th March of the current year for the previous year.

INSTRUMENTS

The questionnaire "Annual report on construction works at constructions – GRADJ -11" is used to carry out this survey, alongside the instructions for completing the questionnaire.

PUBLISHING

Data are published annually, on 15th November of the current year for the previous year, in the annual release "Construction activity" and in the publication "Statistical Yearbook of Republika Srpska".
