ANNUAL REPORT ON PUBLIC WATER SUPPLY SYSTEM

LEGAL BASIS

The survey is carried out pursuant to the Statistical Programme of Republika Srpska for the period 2013-2017 and the Law on Statistics of Republika Srpska ("Official Gazette of Republika Srpska", No. 85/03).

METHODOLOGICAL BASIS

Aim and content

The aim of this statistical survey is to provide annual data on the public water supply system, i.e. data on water capture, by water source, by distribution of water to consumers (households, agriculture, forestry and fishery, industry, and other activities), by water losses and by characteristics of the water supply network.

Observation units/Reporting units

Data on the public water supply system are submitted by public municipal services which run the public water supply system, i.e. those that are engaged in the collection, purification and distribution of water, as well as by enterprises that have a unit engaged in this activity in their composition.

Coverage

This survey covers all business entities registered on the territory of Republika Srpska, which run the public water supply system.

Method and period of data collection

Collection of data within this survey is carried out using the reporting method. Reporting units fill out the questionnaire on the basis of their book-keeping records and technical documentation and based on professional estimate in cases when the necessary documentation and records are not available. Such completed questionnaires are submitted by reporting units to the regional office of the Republika Srpska Institute of Statistics until 1st March of the current year for the previous year.

Protection of confidential data

Only aggregate data for the level of Republika Srpska are published. Confidential data are protected pursuant to Articles 25 and 27 of the Law on Statistics of Republika Srpska ("Official Gazette of Republika Srpska", No. 85/03) and in accordance with the Rules of protection of confidential data.

Definitions of main features - indicators

Public water supply system is a group of connected hydrotechnical facilities and plants, under single management and control, used to capture, collect, purify and distribute water to consumers.

Water intakes (sources) are all capture places of public groundwater and surface water, which serve to supply public water supply systems with water (groundwater, spring, watercourse, reservoir and lake).

Length of water mains refers to the length of water supply pipes from the capture source (water intake) to the reservoir, i.e. to the device for drinking water purification. If there is no reservoir, this refers to the length of water supply pipes from the source to the first branch of the distribution network.

Length of distribution network refers to the length of water supply network from the reservoir to the consumption place, excluding the length of connections and networks in homes.

Compliance with international recommendations and standards

This survey is carried out in accordance with the requirements of the joint OECD/Eurostat questionnaire on inland waters and the UNSD/UNEP questionnaire – environment statistics.

IMPLEMENTATION ORGANISATION

Authorities implementing the statistical survey

Authorised producer of indices of data on consumption is the Republika Srpska Institute of Statistics. Collection of data is carried out in the regional offices of the Republika Srpska Institute of Statistics, while entry and processing of data are the responsibility of the Division for Production Statistics of the Institute.

Obligation to provide data

Reporting units are obliged to submit data to the Republika Srpska Institute of Statistics pursuant to the Law on Statistics of Republika Srpska.

Implementation frequency

Reporting units are obliged to submit data to the relevant regional office of the Republika Srpska Institute of Statistics until 1^{st} March for the previous year. Data are published annually, on 1^{st} September.

Questionnaire
